# CONFLICT FREE CASE MANAGEMENT SURVEY FORUMS

If you receive Case Management through Area Agency Services then you may have heard the terms conflict free case management, or conflict of interest and you may be wondering what this means.

The Center for Medicaid and Medicare Services (CMS) is requiring New Hampshire to make changes in two areas of the service delivery system:

- Conflict of Interest in Case Management to be in compliance with the Home and Community Based Setting (HCBS) Regulations requiring the separation of Case management (Service Coordination) and direct service delivery; and
- 2. New Hampshire's Organized Health Care Delivery System, relating to the payment process for providers
